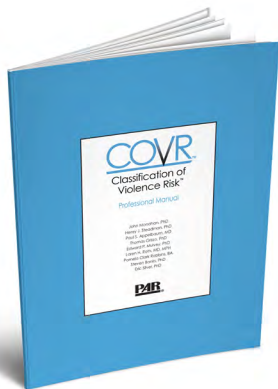


Better understand offenders' risks and needs— and make better risk management decisions



Estimate violence risk after discharge

The **Classification of Violence Risk™ (COVR™)** is an interactive software program that guides you through a brief chart review and a 10-minute interview with the patient (ages 18 to 60 years) to create a statistically valid estimate of the patient's violence risk after discharge into the community. Administration time is 10 minutes. Available as a software download.

Determine if violent individuals need to be separated from prospective targets

Designed on the basic hypothesis that an individual's thought process strongly influences his or her behavior, the **Firestone Assessment of Violent Thoughts™ (FAVT™)** measures different types of thoughts that have been found to predispose an individual (ages 18 to 75 years) to violent behavior. Administration time is 15 minutes. An adolescent version is appropriate for individuals ages 11 to 18 years. Available in paper and pencil.

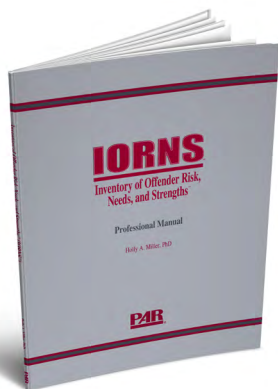

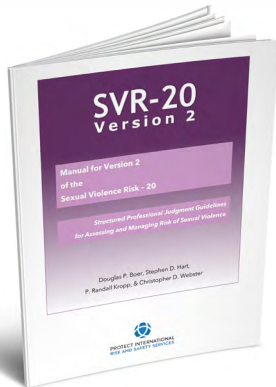


Identify factors related to offender risk, treatment need, and management

Written at a 3rd-grade reading level, the **Inventory of Offender Risk, Needs, and Strengths™ (IORNS™)** is a 130-item self-report measure for individuals ages 18 to 75 years that assesses static risk, dynamic risk/need, and protective strength factors as they relate to recidivism, treatment need, and management. Administration time is 15 to 20 minutes. Available in paper and pencil.

Make better decisions about the management of sex offenders

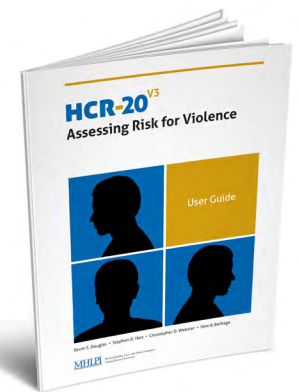
The **Sexual Violence Risk–20, Version 2 (SVR-20 V2)** is a 20-item checklist of risk factors for sexual violence in individuals ages 18 to 65 years. The untimed test specifies which risk factors should be assessed and how the risk assessment should be conducted. Available in paper and pencil.

Make meaningful formulations of violence risk and appropriate risk management plans

Based on the structured professional judgment (SPJ) model of violence risk assessment, the **HCR-20, Version 3: Assessing Risk for Violence (HCR-20 V3)** is a comprehensive set of professional guidelines for the assessment and management of violence risk in individuals ages 18 to 65 years. The test is untimed. Available in paper and pencil.

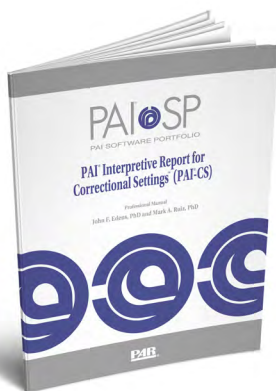

Use the power of the PAI to evaluate offenders' risks and needs

The **PAI[®] Interpretive Report for Correctional Settings[™] Module for the PAI[®]-SP (PAI[®]-CS)** enables correctional psychologists and staff to generate an interpretive report that identifies offenders' (ages 18 to 89 years) risk of institutional misconduct during incarceration, describes offenders' psychosocial needs, and estimates how offenders are likely to respond to incarceration and rehabilitative programs. Administration time is 50 to 60 minutes. Available in paper and pencil, as a software download, or for **online administration and scoring via PARiConnect**.
